WHEREAS the Petitioner above named through his Advocate M/s S. Parineeta, presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction more particularly one in the nature of Writ of Mandamus declaring the action of respondents in dispossessing the petitioner and his co-owners from his fishing rights of Kannikala Cheruvu of Mamadugu village and post, Gangavaram Mandal, Chittoor District by leasing out the fishing rights to the third parties without cancelling the Macha patta of the petitioners as illegal, arbitrary and contrary to the provisions of A.P.Panchayat Raj Act and consequently direct the Respondents not to interfere with the fishing operations of the Petitioner ;

Parineeta, Advocate for the Petitioner, learned GP FOR PANCHAYAT RAJ DEPT. for respondent Nos.1&2 and Sri G.
