WHEREAS the Petitioner above named through his Advocate Sri T V Jaggi Reddy presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ, order or orders specially one in the nature of Writ of Mandamus declaring the acts of the 3rd and 4th respondents in calling the petitioner to police station by making the petitioner to sit in the police station without any crime being registered against the petitioner and threatening the petitioner to vacate the land to an extent of Ac 2.88 cts in R.S No 20/3 and Ac 0.44 cts in S. No 20/4 Bodasakurru Village, Allavaram Mandal, Dr. B.R. Ambedkar Konaseema District under petitioner's lease to the 5th respondent immediately, as illegal, arbitrary, violative of Arts 21 of the Constitution of India and misuse of powers vested with the office of 3rd and 4th respondents and consequently desist the 3rd and 4th respondents from calling the petitioner to the police station and threatening the petitioner to vacate the land stated supra and hand over the same to the 5th respondent.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri T V Jaggi Reddy Advocate for the Petitioner, GP FOR HOME for the Respondent Nos. 1 to 4, directed issue of notice to the Respondent Nos. 5 & 6 herein to show cause as to why this WRIT PETITION should not be admitted.
