WHEREAS the Petitioner above named through her Advocate M SOLOMON RAJU presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly in the nature of WRIT OF MANDAMUS declaring the paper publication notification No. 15/ICDS-RJP/7/2023 dated 07.01.2023 issued by the 4th respondent, thereby notifying Anganwadi Worker Post of Ramnagar ST Colony initially as OH-31 and later modifying the roster point to SC on the same day as illegal, irregular and irrational, contrary to GO Ms.No.21 dated 24.08.2007, GO Ms.No. 38 dated 03.11.2008 and G.O.Rt. NO. 102 dated 28.03.2011 and violative of Articles 14 and 21 of Constitution of India and consequently suspend the paper publication notification No. 15/ICDS-RJP/7/2023 dated 07.01.2023 issued by the 4th respondent and to consider the candidature in terms of G.O.Rt. NO. 102 dated 28.03.2011 and Memo No. 5771/K3/2006, Dt. 05.01.2012 of Director of Women Development and Child Welfare, Andhra Pradesh, Hyderabad .

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri M SOLOMON RAJU Advocate for the Petitioner and of GP FOR SERVICES-II for Respondent Nos. 1 to 4, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

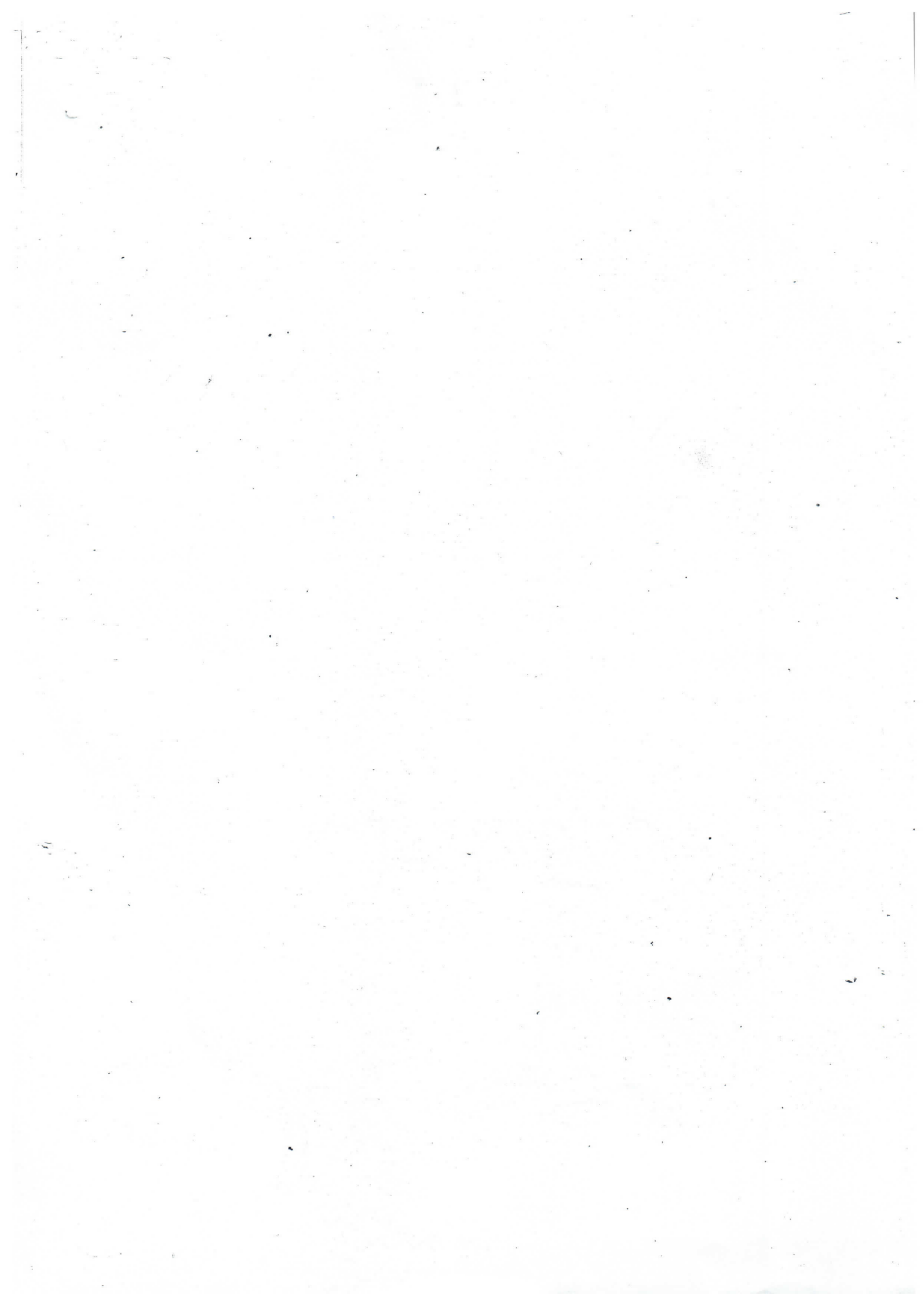
