Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS, declaring action of the respondents more particularly respondents No. 4 in contemplating to dispossess the petitioner from his land in Sy.No. 338 to an extent of Ac. 1.50 cents situated at Sugur Village, Mantralayam Mandal, Kurnool District, as illegal, arbitrary, unjust and also violative of Art. 14, 21 and 300-A of the Constitution of India and DIRECT the respondents not to dispossess the petitioner from his land in Sy.No. 338 to an extent of Ac. 1.50 cents situated at Sugur Village, Mantralayam Mandal, Kurnool District,

Petition under Section 151 of CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to DIRECT the respondents not to dispossess the petitioner from his land in Sy.No. 338 to an extent of Ac. 1.50 cents situated at Sugur Village, Mantralayam Mandal, Kurnool District, Pending disposal of WP 2849 of 2023, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of SRI.BUTTA VIJAYA BHASKER Advocate for the Petitioner, GP FOR REVENUE, for the Respondent Nos. 1 to 4, The Court made the following.

ORDER:

The case of the petitioner herein is that the petitioner was granted patta of the agricultural land vide R.C.B.No.66/2011 dated 25-03-2011 under 15(3) of Board Standing Orders and the petitioner name is recorded in revenue records and was issued pattadar pass book. It appears from the affidavit filed in support of the Writ Petition that, a notice was issued under Section 7 of Act 3, of the A.P.Land encroachment Act, 1905 and the petitioner herein has submitted his explanation to the said notice on 26.09.2022. The grievance of the petitioner herein is that, till today the respondents have not passed any orders on the explanation and now the respondents are trying to interfere with the possession of the petitioner's property. Counter-affidavit is required to hear the dispute.

Hence, there shall be an interim direction to the respondents not to interfere with the possession of the petitioner herein for the land issued, vide R.C.B.No.66/2011 dated 25-03-2011.

Post the matter after four (04) weeks, for filing counter-affidavit.

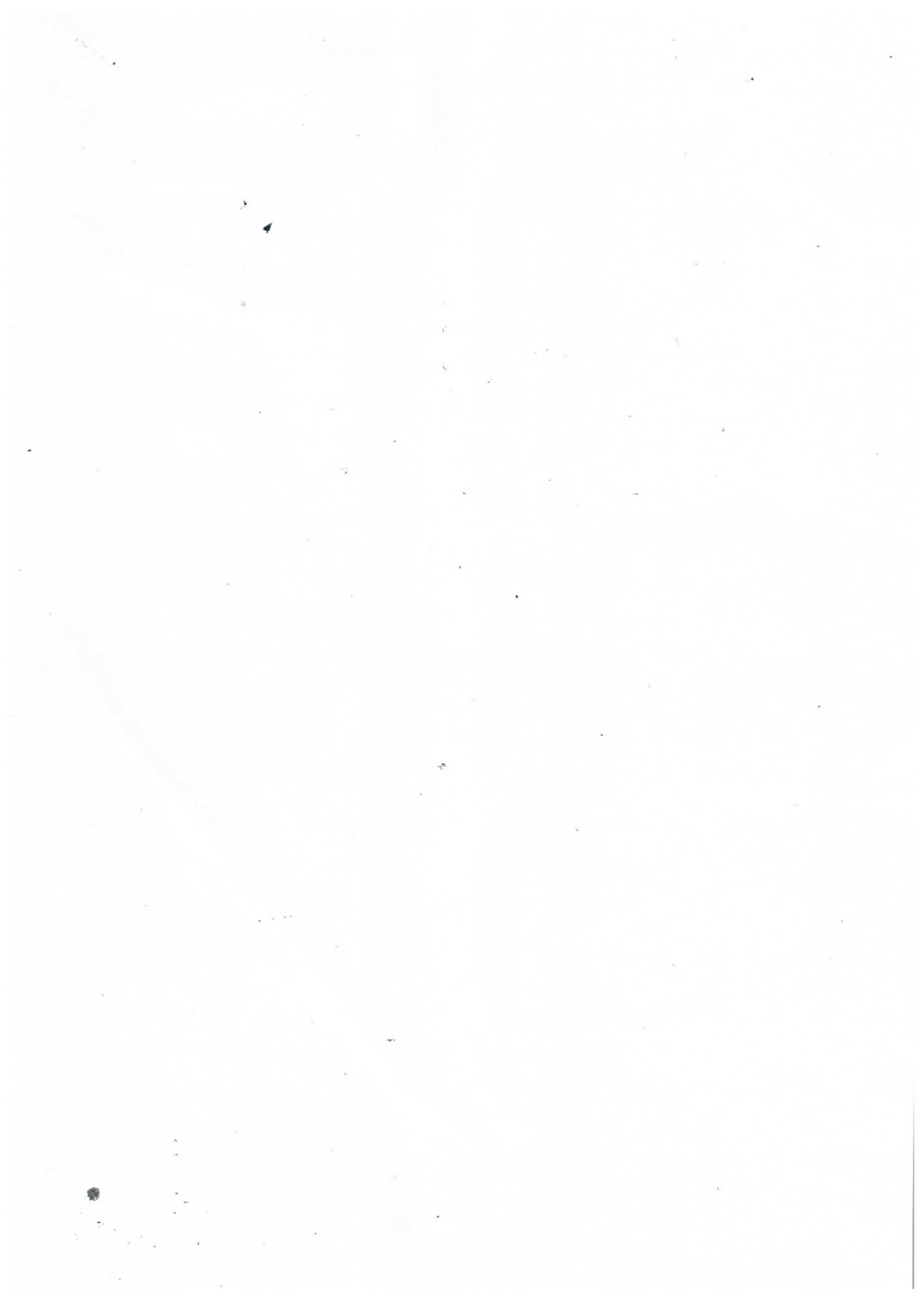
