Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the action, things and deeds of Respondents in trying to lay the road (from Gudivada-Machilipatnam Road to APTIDCO Houses (Andhra Pradesh Township and Infrastructure Development Corporation) through Petitioners' house Plot Nos. 1, 2 & 5 situated in Sy.No.50, Gangadarapuram Village, Bommuluru Gram Panchayat, Gudivada Mandal, Krishna District without any due procedure which is illegal, irregular, arbitrary, unconstitutional, against to the Principles of Natural Justice, contra to the provisions of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and in violation of Articles 14, 19, 21 and 300-A of Constitution of India, consequently direct the Respondents not to interfere or occupy the Petitioners' house Plot Nos. 1, 2 and 5 situated in Sy.No. 50, Gangadarapuram Village, Bommuluru Gram Panchayat, Gudivada Mandal, Krishna District.
