WHEREAS the Petitioner above named through his Advocate Smt. Kavitha Gottipati presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, to declare the action of the respondents in not releasing the bills for an amount of Rs. 3,25,506/- (Rs.97,344/- + Rs. 97,695/- + Rs. 48,457/- + 44,928/- + Rs. 37082/-) even after finalizing the bills payable to the petitioner in relation to the execution of various works i.e. Replacement and erection Grating of 12 size fixed along the pool at swimming pool, Replacement of Hub and Distribution and suction sweeper with nipples washers pressure gauge at swimming pool, Providing JCB's to create path way and to remove Jungle at Dumping yard, Replacement and erection under water LED Lights (ABS Fibre Plastic)Led Driver (SMPS) 12V -15 Watt AC To DC along the pool at swimming pool, Construction of culvert at MRO office and alamaras at health care center in Kandukur Municipality under Municipal General Funds grant vide agreement Nos. 61/2018-19, 63/2018-19, 13/2018-19, 42/2018-19, 31A/2018-19 dated 06-03-2019, 06-03-2019, 30-07-2018, 15-02-2019, 08-11-2018 respectively as the same is illegal, arbitrary and unjust and consequently direct the respondents to release an amount of Rs. 3,25,506/- (Rs.97,344/- + Rs. 97,695/- + Rs. 48,457/- + Rs. 44,928/- + Rs. 37082/-) to the petitioner in respect of execution of afore mentioned works forthwith.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Smt. Kavitha Gottipati, Advocate for the Petitioner, learned GP for Municipal Administration for respondent Nos.1 and 3, learned GP for Finance for respondent No.2, Sri. M. Manohar Reddy, Advocate for respondent Nos.4 and 5 directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
