This Writ Petition is filed under Article 226 of Constitution of India with the following prayer:

“...to issue a writ, order or direction more particularly one in the nature of writ of mandamus declaring the action of the respondent police in interfering in civil matter and forcing the petitioners to vacate from their huts where they are living since several years without following any procedure under law and representation is pending before the revenue authorities for allotment of house sites to them in Sy.No.111/1,2,3,4,5,6 Situated at Ambapuram, 31 Division Bit No.1, Nellore, SPSR Nellore District as illegal and arbitrary, unjust and violative of Articles 14, 21 of the Constitution of India, and consequently direct the respondent police not to interfere in respect of partitioners huts in above property....”

2. When the matter is taken up for hearing, Sri P.Ajay Babu, learned Assistant Government Pleader for Home, on written instructions, would submit that on the complaint made by the Tahsildar, Nellore Rural Mandal, a case in Cr.No.79 of 2023 under Sections 447, 427, 188 r/w 34 of IPC of Vedayapalem P.S., on 21.03.2023 against the petitioners. He would further submit that regarding the said crime, the petitioners were called to the police station. The police never interfered in the civil disputes.

3. Learned counsel for the petitioners would submit that the Court may pass appropriate Orders.

4. Recording the above said submissions, this Writ Petition is disposed of. However, the police are directed to follow the due process of law, regarding

the crime which has been registered against the petitioners. No order as to costs.

As a sequel thereto, miscellaneous petitions pending, if any, shall stand closed.
