I.A.Nos.3 & 4 of 2024 in W.P. No.11812 of 2005

These applications are filed by the petitioners/proposed respondents seeking to implead them as respondent No.89 in the writ petition.

We have gone through the applications and also heard the learned counsel for the parties.

For the reasons stated in the accompanying affidavits filed in support of the petitions and those urged at the time of hearing, these applications are allowed subject to just exceptions. The petitioners herein shall be

incorporated as party respondents in the writ petition and other miscellaneous applications and shall figure as respondent Nos.89 and 90.

The cause title be amended accordingly.

I.A.No.2 of 2024 in W.P. No.11812 of 2005

This application is filed seeking permission for exchange of land admeasuring Ac.4-64 cents in Sy.No.206/1 of Cheruvu Village, Mudinepalli Mandal, Eluru District belonging to Sri Jagannadha Swamy Vari Devasthanam in favour of newly impleaded respondent No.90 – Potula Sai Chowdary in exchange of his private land admeasuring approximately Ac.5-00 cents in Sy.Nos.226/1 and 226/2 in favour of the Devasthanam.

There is nothing placed on record which would show as to whether the newly added respondent No.90 has valid title to the property which is sought to be exchanged with the temple property. The value of the temple property which is sought to be exchanged as also the value of the property which belongs to respondent No.90 are also not before us.

We, therefore, direct the parties to place the relevant material in regard to the aforementioned proceedings. The Endowments Department shall also file the response to the present application and also verify the title of respondent No.90 with regard to the property in question as also its fair value.
