WHEREAS the Petitioner above named through her Advocate Sri RAMBABU KOPPINEEDI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or order or direction more particularly one in the nature of Writ of MANDAMUS declare the 2nd Respondent's Circular No. 1813129/FIN01-HR/212/2022-HR-IV dated 23-09-2022 to the extent of Paragraph No. 6 and 5th Respondent's Proceedings No. S.III (3)/9358/Ret/99-2000 (62D) dated 14-03-2023 as illegal, arbitrary and violative of Articles 14, 16 and 21 of the Constitution of India and consequently set aside the 2nd Respondent's Circular No. 1813129/FIN01-HR/212/2022-HR-IV dated 23-09-2022 to the extent of Paragraph No. 6 and 5th Respondent's Proceedings No. S.III (3)/9358/Ret/99-2000 (62D) dated 14-03-2023.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri Rambabu Koppineedi, Advocate for the Petitioner and GP for Higher Education for the Respondent No.1 & 3 and GP for Finance for the Respondent No.2 and Sri V.Sai Kumar, Standing Counsel for the Respondent Nos.4 & 5, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
