WHEREAS the Petitioner above named through his Advocate Sri M Vidyasagar presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction, more particularly a writ in the nature of Writ of MANDAMUS declaring the proceedings of the 5th respondent i.e., Commissioner of Endowments, AP, Vijayawada issued in K.Dis.No.B2/COE-12026(31)/26/2022, dated 19-10-2022 appointing respondents 6 to 13 as trustees to Sri Mahaganapathi, Prasanna Venkateswara, Shiridi

Saibaba, Ayyappa Swamy Temples, Seethammadhara, Visakhapatnam, rep.by its Executive Officer, as bad, illegal, arbitrary, opposed to law, contrary to the provisions of the Endowments Act and also the rules framed under G.O.Rt.No.258.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri M Vidyasagar, Advocate for the Petitioner and of GP for Endowments for Respondent Nos.1, 2, 4 & 5, Sri B. 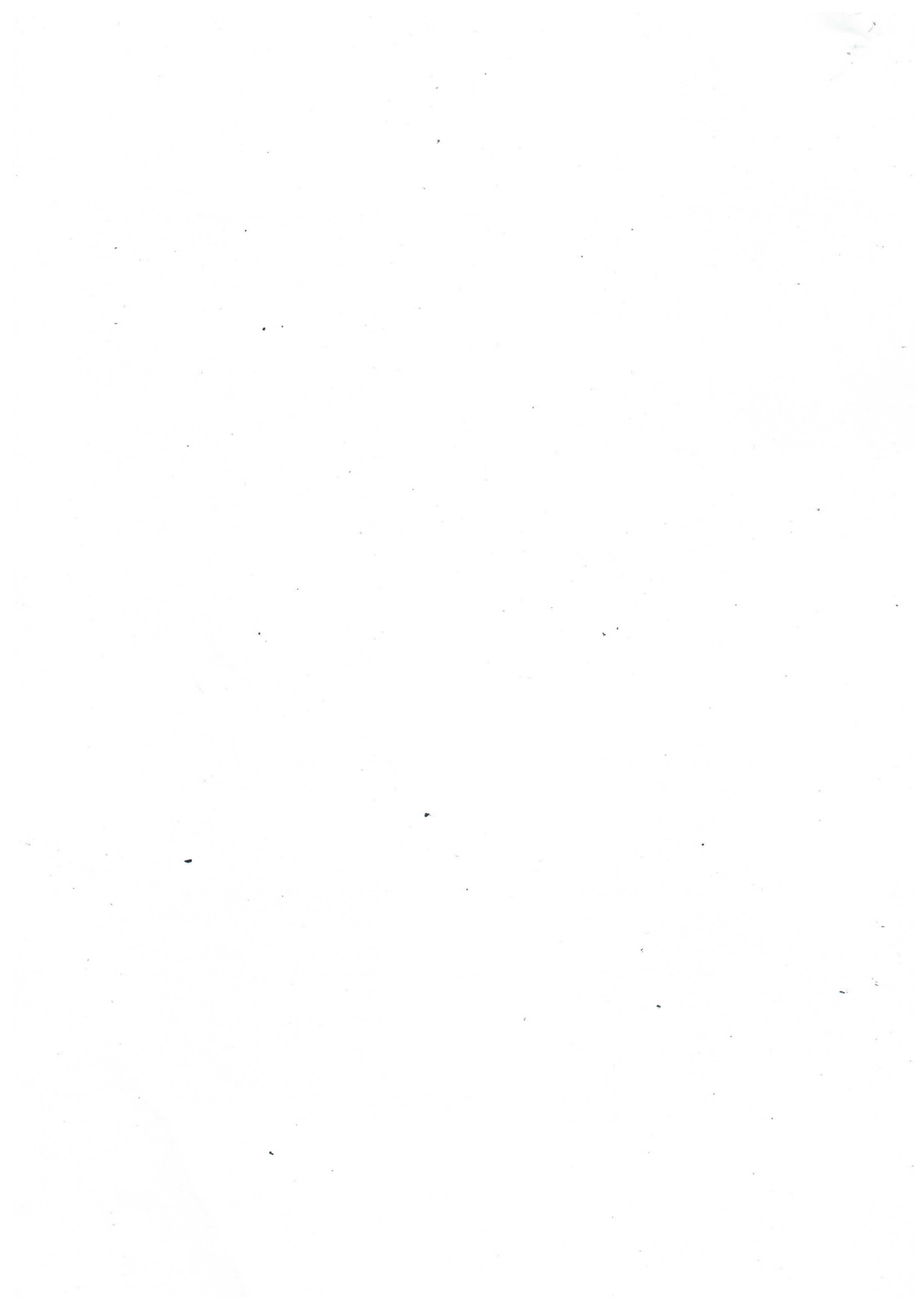
