No. E2/15021/475/2022 dated 21.03.2023 deleting Sri Mukthi Ramalingeswaraswamy Devasthanam, Rameswaram Village, Proddatur Mandal, YSR Kadapa District from the charge of the petitioner as bad, illegal, arbitrary and violative of Articles 14, 16 & 21 of Constitution of India and consequently set aside the same.
