Reddy Venkata Ramana, Advocate for the Petitioner, learned GP for Home for respondent Nos.1 to 4 and Sri. N. Srihari, Standing Counsel for respondent No.5 , directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

"Learned Government Pleader for Home representing R-1 to R-4 submitted that R-5 and R-6 have to answer in this issue. He further submitted that R-1 to R-4 have nothing to do with the relief claimed by the petitioner since it is an issue of management of festival of the temple.

Learned counsel for the petitioner is permitted to take out personal service of notice to the respondents No.5 and 6 through RPAD and file proof thereof."

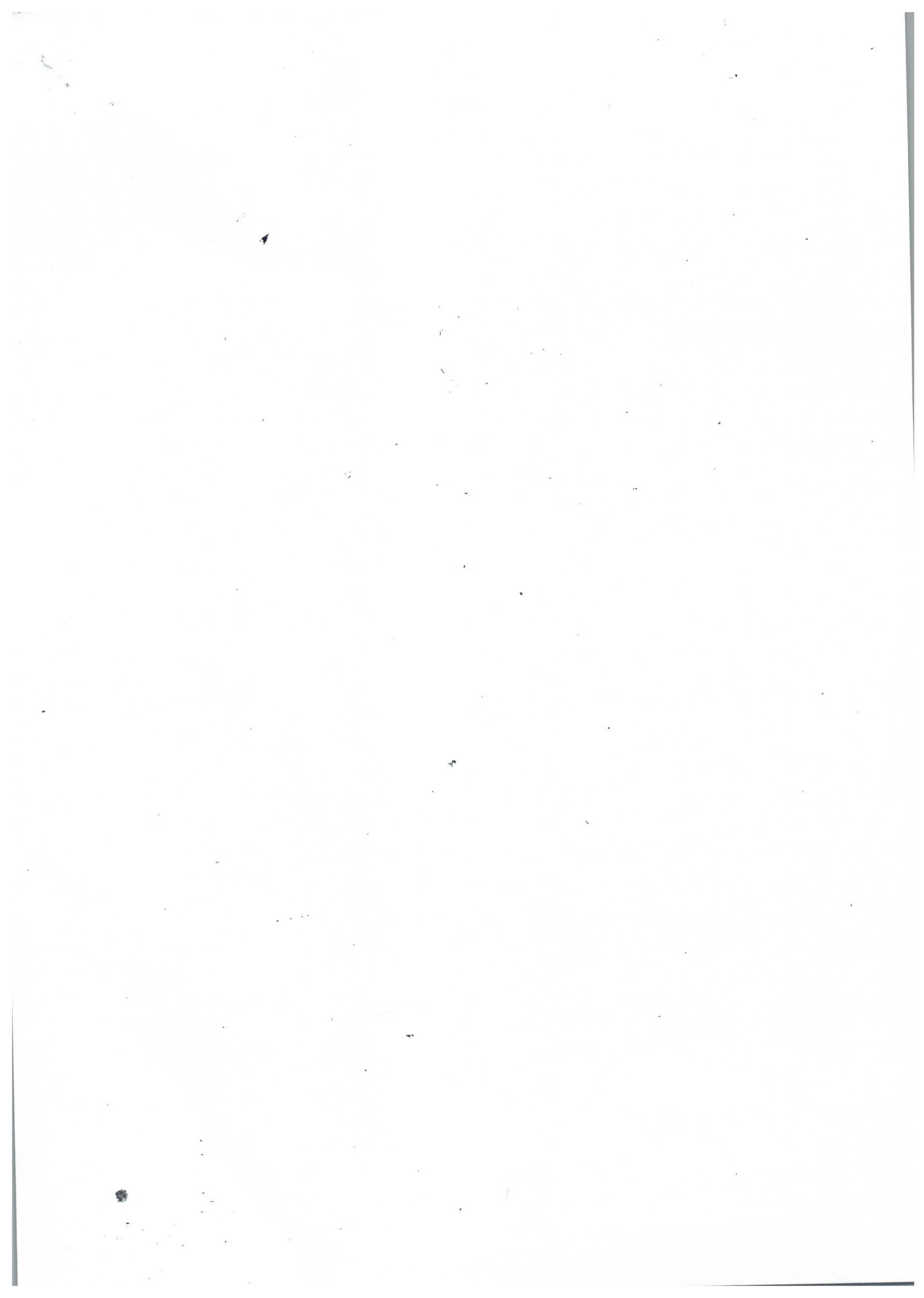
