Akhil Krishnan, presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction particularly one in the nature of Writ of Mandamus to declare the inaction of the Respondents in appointing the Petitioner as 'Data Entry Operator' on regular basis pursuant to issuance of G.O.Ms. No.47 dated 24.02.2023, who is already working as a 'Data Entry Operator' in District Legal Service Authority, Eluru on a temporary basis since 2017 as illegal, unreasonable, contrary and violative of Articles 14, 16, 21 and 309 of the Constitution of India and consequently, to direct the Respondent No.1 to appoint the Petitioner as a Data Entry Operator in District Legal Service Authority, Eluru ;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. Akhil Krishnan, Advocate for the Petitioner, learned GP for Services-I for respondent No.1 & 2, and Sri. S. Lakshmi Narayana Reddy, Standing Counsel for respondent Nos.3,4 and 5,
