On being mentioned by Mr. Matrugupta Misra, learned counsel for the Intervenors in IA Nos. 1163 to 1172 of 2020, we note that an inadvertent mistake has crept in while describing the cause title in the judgment passed on 02.08.2021 in the above mentioned Appeal No.229 of 2018 i.e. name of Sri Chamundeswari Sugars Ltd. in IA No. 1170 of 2020 has not mentioned.
