1. On 16th August, 2018, the above matters had appeared on board under the caption of 'ad-interim reliefs'. No ad-interim reliefs were granted on that day and the Notices of Motion were directed to be placed for hearing on 28th August, 2018, subject to numbering. The above suits are not numbered till date.
