2. Mr. V Vinod Kumar, learned counsel for the respondents.
3. MA/462/2022 is filed by the applicant in OA for condonation of delay of 441 days in filing the review application. Neither the applicant nor his counsel is present today. It indicates that the applicant as well as his counsel lost interest in prosecuting the matter further. Further, in terms of Section 17(1) of the Central Administrative Tribunal(Procedure) Rules, 1987, 'no application for review shall be entertained unless it is filed within thirty days from the date of receipt of copy of the order sought to be reviewed'. This Tribunal has no power to condone the delay in filing review application. In view of the above, MA/462/2022 is dismissed. Accordingly, RASR No.599/2021 is rejected.
