Applicant contends that he is entitled to be promoted from the post of Private Secretary to Principal Private Secretary (Annexure A-4) and also to the enhanced benefits, etc. Applicant submitted Annexure A-5 representation and that was not disposed of.

The applicant is permitted to make additional representation within two weeks from today which also will be considered by the 2nd respondent. The disposal of the representations shall be done within two months from the date of receipt of the additional representation, which may be filed by the applicant.
