It was submitted by the learned counsel for the applicant that the applicant has since retired and accordingly he has been instructed that the Original Application need not be pursued. This is recorded.

2. In this circumstance, the Original Application is closed without prejudice to the right of the applicant to seek relief in relation to other relief, if any, other than the reliefs claimed in the Original Application. No costs.
