**ORDER (ORAL)**

**BY HON'BLE MR. A. MUKHOPADHAYA, MEMBER (A)**

At the very outset, Shri Sunil Kumar Singh, learned counsel for the applicant submitted that the applicant had given a representation dated 08.07.2020, (Annexure A-1) to the respondents requesting that the age of superannuation in his case be increased from the present age of 60 years to 65 years. Learned counsel submitted that since the applicant is due to superannuate on 31.12.2020, he would be satisfied if the representation given by him to the respondents on 08.07.2020 is decided by them in accordance with law before his superannuation after affording him the opportunity of a personal hearing. Ms. Prayagmati Gupta, learned counsel for the respondents, has no objection to this.

2. Accordingly, looking to the limited nature of the plea and without entering into the merits of the case, I deem it appropriate to dispose of this O.A at the stage of admission itself with a direction to the respondents to decide the representation dated 08.07.2020 given to them by the applicant within a period of one month from the date of receipt of certified copy of this order, by way of a reasoned and speaking order in accordance with law. The representation shall be decided after affording the applicant an opportunity of personal hearing.

3. Accordingly, the original application No. 272/2020 is disposed of. There shall be no orders on costs.
