Hon'ble Mr. Tarun Shridhar, Member(A):-

At the outset, learned counsel for the applicants submits that the issue at stake in the present O.A. is being agitated before the Hon'ble Supreme Court in Civil Appeal No. 3110/2016. Accordingly, it will be a fruitless exercise to agitate this issue in the current O.A. and it could be disposed of with a direction to both the parties that they shall be bound by the final decision/judgment rendered by the Hon'ble Supreme Court.

2. Learned counsel for the respondents confirms this position.



3. Accordingly, the present O.A. stands disposed of with an observation that the parties in the O.A. shall abide by the decision/judgment that the Hon'ble Supreme Court renders in the aforementioned Civil Appeal.

4. Associated M.As. also stand disposed of accordingly.
