ORAL ORDER

Heard Sri S.A.K. Mynoddin, learned counsel for the applicant.
Mr. E. Peddanna, learned Standing Counsel for the State Government of Andhra Pradesh takes notice for Respondents No.1 to 3. Mr. M. Venkata Swamy represents Mrs. K. Rajitha, learned Senior Central Government Standing Counsel appearing for the 4th Respondent.

2. The applicant submits that the 1st Respondent has notified six vacancies to be filled with eligible State Civil Service Officers for the year 2013 and three more retirement vacancies up to 2.6.2014. It is the case of the applicant that he is eligible to be considered for inclusion in the select list of officers for conferment of IAS for the years 2013, 2014 & 2015 as he has fulfilled all the required conditions of non-completion of 54 years as on 1.1.2013 and also as he has been regularized as a substantive candidate in the State Civil Service. Further he has more than eight years continuous service in the grade of Deputy Collector as on 1.1.2013. As such he had



submitted Annex.A-5 & A-6 representations to the 1st Respondent to consider inclusion of his name in the select list of officers for conferment of IAS for the years 2013, 2014 & 2015. The applicant submits that so far, the respondents have not processed his representation for inclusion of his name in the select list of officers.

3. Mr. E. Peddanna, learned Standing Counsel for Respondents No.1 to 3 submits that the 1st Respondent has already directed the 3rd Respondent to furnish a detailed report on the representation submitted by the applicant and also submitted a copy of the Memorandum dated 1.6.2017 issued by the 1st Respondent in this regard.

4. In the above circumstances and also in view of the fact that the representation of the applicant is still pending consideration, the O.A. is disposed of at the admission stage with the consent of the parties, with a direction to the 1st Respondent to consider the representation and pass appropriate and reasoned orders in accordance with law and communicate the same to the applicant within a period of two months from the date of receipt of a copy of the order. No costs.
