Per: SURESH KUMAR MONGA, MEMBER (J):

At the very outset Sh. Sanjay Goyal, learned Senior Central Government Standing Counsel, while representing respondents No. 1 to 4, produced a copy of the notice dated 27.07.2022 vide which the respondents have invited the grievances against the Annual Transfer Drive-2022 from the eligible employees. Learned Counsel stated that since a committee has been constituted by the respondents to deal with the grievances of all the affected employees, therefore, the

present Original Application being pre-mature cannot be entertained.

3. In view of the aforesaid notice dated 27.07.2022, we, however, deem it appropriate to dispose of the present Original Application with the observations that if the applicant submits her grievance before the competent authority, the same shall be considered in accordance with law and a reasoned and speaking order shall be passed within a period of four weeks from today.

4. Ordered accordingly. However, there shall be no orders so as to costs.
