ORAL ORDER

{ Per Hon'ble Mrs. Minnie Mathew, Member (Admn.) }

Heard Mr. Narinderpal Singh, learned counsel for the applicant.
Mrs. K. Rajitha, learned Senior Central Govt. Standing Counsel takes notice for the respondents.

2. The applicant is a Section Supervisor working in the O/o the 3rd Respondent. She had requested for sanction of leave on medical grounds on 27.3.2017 to 21.4.2017 with a further extension from 22.4.2017 to 28.4.2017 for leg injury and lower back pain. However, the respondents directed her to go for a second medical opinion before the Superintendent of Osmania General Hospital, Hyderabad on 29.4.2017. Accordingly, the applicant has appeared before a Medical Board on 29.4.2017 and completed all the tests and examinations by 5.5.2017. However, till date the Department has not passed any orders on the medical opinion received. It is the case of the applicant that in the absence of the second medical report, she is unable to obtain medical fitness to join duty. She has accordingly submitted detailed representations on 19.4.2017, 25.5.2017, 19.6.2017 & legal notice dated 7.7.2017. In spite of the repeated representations, the respondents have not taken any action on the

second medical opinion that has been obtained by them. She also submits that she is eligible to join duty only when she is declared medically fit.



3. I have considered the submissions and also the material on record. It is seen that the applicant has submitted Annex.A-1 & A-6 representations dated 25.5.2017 & 19.6.2017 to the 3rd Respondent & 4th Respondents respectively ventilating her grievances.

4. In view of the pending representations, the O.A. is disposed of at admission stage with a direction to the respondents to consider the Annex.A-1 & 1-6 representations and pass appropriate orders in accordance with law within four weeks from the date of receipt of a copy of the order. No costs.
