ORDER (Oral):

Applicant is retired as Senior Section Engineer. After working in Central Railways he came over to Southern Railway and finally he

was posted at Thiruvananthapuram Division after working in Palakkad and Chennai Divisions. He had taken up the matter with the respondents and finally respondent No. 3 issued Annexure A-5 communication asking him to take up the matter with respondent No.2.

2. Learned Standing Counsel for the Railways takes notice.

3. After hearing both sides for sometime, learned counsel for the applicant submitted that he would be satisfied if permission is given to the applicant to submit a comprehensive representation to respondent No. 2 and if a direction is given to the said respondent to dispose of the same within a time frame fixed by this Tribunal.

4. Accordingly, we dispose of the O.A at the admission stage itself while permitting the applicant to file a comprehensive representation to respondent No. 2. Respondent No. 2 shall consider and pass appropriate and well reasoned order within two months from the date of receipt of a copy of the representation. Applicant shall file representation within 10 days from today.

5. The O.A is disposed of as above. No order as to costs.
