None has appeared nor is there any adjournment request on record. Matter has come up five times earlier on 09.04.2024, 11.07.2024, 20.08.2024, 26.11.2024 and 04.12.2024 and this is the sixth time. It appears that the party is not interested to pursue the appeal. Therefore, as per the inherent power vested in this Tribunal as noted in 2009 (244) ELT 497 (Bom.) CHEMIPOL Vs.
