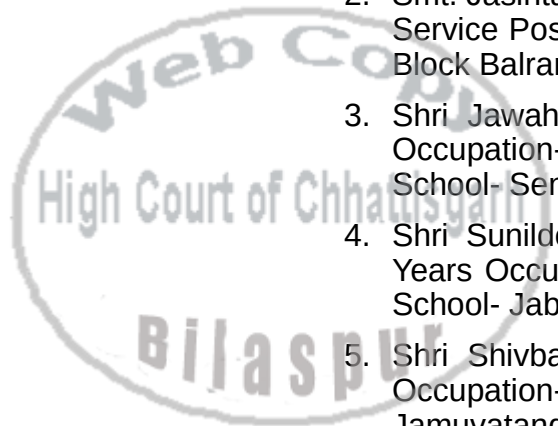

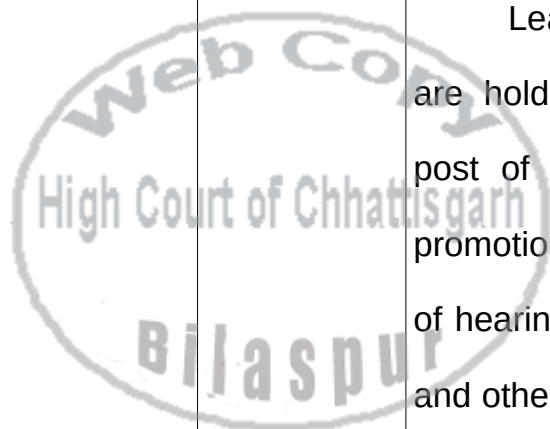
Heard.

Issue notice to respondents.

Learned State Counsel accepts notice on behalf of respondents, hence, process fee is not required to be paid. He prays for and is granted four weeks' time to file reply.

Also heard on application for grant of interim relief.

Learned counsel for petitioners submits that petitioners, who are holding the post of Assistant Teacher (LB) were promoted to the post of Head Master. However vide impugned order, order of promotion of petitioners was cancelled without affording opportunity of hearing. He also submits that identical case WPS- 7358 of 2022 and other connected matters came up for hearing on 04.11.2022 and this Court considering the submissions made by learned counsel for petitioners therein, passed detailed order, wherein learned counsel for the State submitted that Collector and DEO of respective districts issued clarificatory orders, mentioning that order of promotion has not been cancelled, only place of posting is stayed and posting of petitioners would be made pursuant to counselling to be conducted by the Committee constituted by the Collector, and interim orders have been passed in favour of petitioners therein, directing them to work on their promoted post mentioned in their order of promotion.





Hence similar order may be passed in this case also.

Learned State counsel does not dispute the submission with respect to order passed in identical case with respect to promoted Head Master of District – Korba and Balrampur.

In view of above submissions made by learned counsel for parties, the order of counseling for posting of promoted Head Master to be conducted by Committee constituted by Collector is already stayed, purely as an interim measure, it is directed that effect and operation of impugned order shall remain stayed till the next date of hearing.
