Order On Board

1. Learned counsel for petitioner submits that respondent No.2 issued an advertisement for appointment on the post of Anganbadi Worker at Village Panchayat Banikhar, Block – Kasdol, District Balodabazar – Bhatapara. Petitioner along with six other submitted their application forms, however, five applicants have been held ineligible on the ground that documents submitted along with application is not bearing the joint seal and signature of Sarpanch and Secretary. Petitioner submitted objection before respondent No.4/Project Officer mentioning therein that at the time of submitting Form due to strike of State Government employees particularly Patwaries and Secretaries, residential certificate could not be signed by Sarpanch and Secretary both. Considering last date for submission of application Form, petitioner submitted application along-with certificate issued under signature of Sarpanch. Objection submitted by petitioner is pending consideration till date. He further contended that as per his information, recruitment proceeding has not been completed as appointment order has not been issued till date.
2. Learned State Counsel submits that perusal of Annexure P-1 would show that based on list published of eligible or ineligible candidates' objection were called. However, he submits that if





representation/objection submitted by petitioner is not yet decided as stated by counsel for petitioner, it will be decided in accordance with law expeditiously.

3. Heard learned counsel for the respective parties, perused documents placed on record.
4. Considering entire facts and circumstances of the case, submission of counsel for the respective parties, particularly Annexure P-1 list published mentioning candidates to be eligible or ineligible for their consideration for appointment on the post of Anganwadi worker and calling objection from aggrieved persons, as stated petitioner's objection is not decided, writ petition is disposed of directing respondent No.4 to take decision on representation/objection of petitioner dated 28.10.2022 (Annexure P-4) in accordance with law, expeditiously, preferably within an outer limit of 'two weeks' from the date of receipt of copy of order passed by this Court.
