1. As per the settlement arrived at between the parties, Respondent No.3 / Cholamandalam M.S. General Insurance has hereby agreed to deposit Rs.5,20,000/- (Rupees Five lakhs twenty thousand only) over



and above the compensation awarded by the learned Claims Tribunal within a period of 60 days from today. The said amount of compensation shall not carry any interest, if paid within the period of two months, else it shall carry interest @ 6% per annum from the date of passing of this award till the date of its actual amount.
