1. Challenge in this writ petition is to the cancellation of promotion order of petitioner and constitution of a Committee by the respondent-Collector to consider their place of posting as promoted Head Masters.
2. Various other writ petitions challenging cancellation of promotion order of Head Masters on identical grounds under similar facts are disposed off by this Court vide order dated 13.02.2023 lead case being W.P.(S) No. 1125 of 2023. Relevant portion of the said order reads thus :-

“15. For the foregoing, the order canceling promotion of petitioners by Collector and consequent order passed by District Education Officer dated 19.10.2022 and 20.10.2022 have already been clarified by order dated 03.11.2022 stating that those orders are not the order cancelling the promotion and further the order of Collector constituting the Committee has been canceled by Collector vide order dated 01.02.2023. The Committee constituted is by District Education Officer who is an appointing authority and Chairman of Promotion Committee of Head Master Primary School to post the promoted Head Master.

16. In the above facts of the case the grievance of petitioners against the order dated 19.10.2022, 20.10.2022, 20.10.2022 and 27.10.2022 is already redressed by the subsequent order dated 03.11.2022 by Collector and District Education Officer and grievance against order dated 20.10.2022 is redressed by the order dated 01.02.2023.”





3. Having regard to the facts and circumstances of the case, this writ petition too is disposed of in identical terms of aforesaid order dated 13.02.2023, passed by this Court in W.P.(S) No. 1125 of 2023.
4. In view of above, writ petition stands disposed of.
