Also heard on IA No.01/2021, an application for grant of stay. Issue notice to the Respondents on this application also, as above. Meanwhile, purely as an interim measure, it is directed that the effect and operation of the award impugned dated 22.01.2021 passed by the Additional Motor Accident Claims Tribunal (FTC), Jashpur, District Jashpur in Claim Case No.82/2018 shall remain stayed, in so



far as the present Appellant is concerned, till the next date of hearing, subject to the Appellant's depositing 75% of the award under Appeal before the concerned Executing Court within a period of two months from today.

Respondents No.1 & 2/Claimants shall be entitled to withdraw the same as per the terms and conditions mentioned in the award impugned.

It is made clear that if any of the conditions is violated, then this order shall lose its efficacy and the award impugned shall become executable forthwith.
