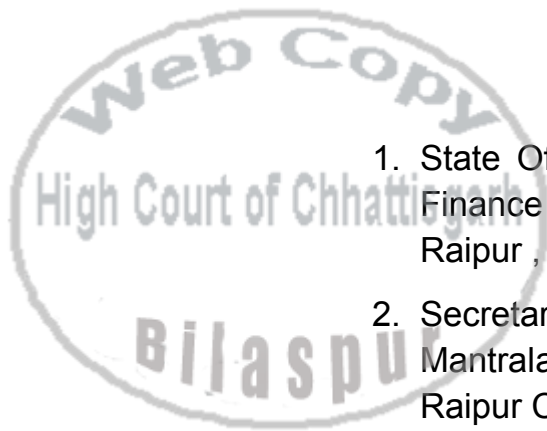

In these bunch of petitions, common issue is involved therefore, they are being heard and decided by this common order.

2. Petitioners are presently working on the post of Data Entry Operators in the office of Zilla Panchayat. They are appointed on contractual basis and the period of appointment has been extended from time to time. The petitioners are claiming revised honorarium on the basis of recommendation made by respondent No.3- State Project Director, Raipur, Chhattisgarh dated 25.10.2021 and 21.06.2021.

3. Counsel for the petitioners would submit that though the respondent No.3 has recommended for grant of revised pay matrix level 6 vide recommendation dated 25.10.2021 and 21.06.2021, but till date same has not been granted by the respondent/authorities. Thus, he would pray for a direction to the respondent/authorities who recommended the matter of the petitioners for grant of revised matrix level 6 but rejected the representation on 21.06.2021.

4. Counsel for the State would submit that on 21.06.2021, the respondent No.3 denied the petitioners for grant of revised matrix level 6 but later on, on 25.10.2021 the authority has recommended for grant of revised honorarium.



5. I have heard counsel for the parties.

6. Considering the fact that after passing the order dated 21.06.2021, respondent No.3 himself has referred the matter to the Secretary, State of Chhattisgarh, Panchayat and Rural Development Department for grant of revised honorarium and revised pay matrix level 6 to the petitioners but the same has not been finalized till date. The order dated 21.06.2021 becomes irrelevant as later on the authority himself has recommended the grievance of the petitioners to the higher authorities.

7. At this stage, the petitioners are permitted to make representation before respondent authorities and in turn the respondent authorities are directed to consider the representation of the petitioners in the light of the letter dated 25.10.2021 issued by the respondent No.3 for grant of revised honorarium applying the pay matrix level 6 within the outer limit of two months from date of the receipt of copy of this order.

8. With these observation and direction these petitions stand disposed of.
