1. This batch of writ petitions has been preferred by the petitioners herein questioning the constitutionality of Chhattisgarh Civil Service (Special Provision for



Appointment of Women) Rules, 1997 in which Proviso to Rule 4 has been inserted, which states as under :-

“Provided that this relaxation shall be to the extent that in no case the upper age limit of the female candidates for direct recruitment shall exceed 45 years of age.”

2. This Court, while entertaining these writ petitions, vide order dated 27/12/2021, allowed the petitioners, who are women candidates, to appear in the examination of Anganbadi Supervisor and thereafter, their results were declared on 23/03/2022 and all the petitioners in this batch of writ petitions were declared unsuccessful as submitted by learned counsel for the petitioners, as such, this batch of writ petitions has become infructuous.
3. Accordingly, these writ petitions stand dismissed having become infructuous.
