1. As per office noting, reply to the captioned IA was filed on behalf of defendant no.1.
2. Ld. Counsel for plaintiff submits that he has not received copy of the reply. Ld. Counsel for defendant no.1 submits that he will supply the same within one week. Let the same be supplied accordingly. Thereafter, the plaintiff may file rejoinder to the reply of defendant no.1 within four weeks.
3. Ld. Counsel for defendant no.2 submits that he does not wish to file any reply to the captioned IA.



4. No reply to the captioned IA has been filed on behalf of the defendants no.3 and 4. Last opportunity is granted to the said defendants for filing reply to the captioned IA within four weeks and rejoinder thereto be filed within two weeks thereafter.

5. As per office noting for 24.05.2023, the defendant no.4 was also served. However, there is no appearance on behalf of defendant no.4.
6. Separate written statements and affidavits of admission/denial of documents were filed on behalf of defendant no.1 and defendant no.2.
7. Ld. Counsel for plaintiff has submitted that he has not received copies of written statements filed on behalf of defendants no.1 and 2.
8. Ld. Counsel for defendant no.2 has supplied physical copy of written statement and affidavit of admission/denial of documents to Ld. Counsel for plaintiff today before the undersigned. The plaintiff may file replication and affidavit of admission/denial of documents qua defendant no.2 within 30 days from today.
9. Ld. Counsel for defendant no.1 has submitted that he will supply copy of the written statement and affidavit of admission/denial to Ld. Counsel for plaintiff within one week. Let the same be supplied accordingly. Thereafter, the plaintiff may file replication alongwith affidavit of admission/denial of documents qua defendant no.1 as per law.
- 10.No written statement and affidavit of admission/denial of documents has been filed by defendants no.3 and 4.



11. The defendants no.3 and 4 may file written statement alongwith affidavit of admission/denial of documents as per law with advance copy to the opposite party, who may file replication alongwith affidavit of admission/denial of documents thereafter as per law.
12. Let the pleadings be completed as per law.
13. Re-notify the matter for completion of pleadings and further proceedings on **25th April, 2024**.
