It is stated by learned counsel for the plaintiff that she has already sent draft of Joint Schedule of the documents to learned counsels for the defendant no.1 to 3 three days back. The learned proxy counsel for the defendant no.1&3, who has joined the proceeding through VC, insists that he has not received copy of draft Joint Schedule of the documents. He is directed to leave his email ID in the chat box and thereafter, learned counsel for the plaintiff is directed to send copy of draft Joint Schedule of the documents to learned counsel for the defendant no.1 & 3 during the course of day on the email ID provided today by learned counsel for the defendant no.1&3.
