moved by plaintiff for impleading the LRs of defendant
no.3 and defendant no.5**

As per record, the reply to captioned IA filed by LRs of deceased defendant no.3 is already on record. As per office note, rejoinder filed by the applicant/plaintiff is also on record. **Thus, pleadings qua LRs of deceased defendant no.3 are complete.**

Vakalatnama has not been on behalf of defendant no.5(b) till date. Learned counsel for the said defendant seeks some time to file the same. AT request, the same be filed within two weeks as last and final opportunity.

It already stated by learned counsel for the defendant no.5(a) to (d) has already stated that the said



proposed LRs do not wish to file any reply to captioned IA.

It is already stated by other non-applicants that they do not wish to file any reply to captioned IA as they have no objection, if captioned IA is allowed. It be noted that the captioned IA already stands allowed qua deceased defendant no.5 vide order dated 24.01.2023.

Adjournment is sought by proxy counsel for the plaintiff on the ground that main counsel is not available today as is busy in another matter before the Hon'ble Supreme Court of India.

Re-notify captioned IA for completion of pleadings qua defendant no.3 and consideration on the next date of hearing.
