

**PW-2. Statement of Sh. Avtar Singh aged 47 years,
son of Sh.Nasib Singh, resident of VPO
Dulehar, Tehsil Haroli, District Una, HP.**

**On S.A.

Stated that I am a labourer.

2. On 07.04.2023 my relative Kashmir Lal told me telephonically that body of Rajinder Kumar @ Ravi was found in the bushes near crusher at Gondpur Jaichand. I went thereto. About 200-300 persons were present on the spot. One of them told that he had seen two boys with the deceased Rajinder Kumar @ Ravi and showed me photograph of one of the accused present in the court (witness pointed to accused Gagandeep) and enquired as to whether I had seen him. I told him that I had seen the person seen in the photograph with deceased Rajinder Kumar previous day on 06.04.2023 around 1:30 p.m. coming from the bushes alongwith one more boy (witness pointed to accused Vishal Sahota). I also told him that both the boys/accused were scared and were looking behind and staring at me. I also told him that boy/accused Vishal Sahota had kept his wet shirt on his head and the other boy/accused Gagandeep had kept parna (towel) around his neck like a muflar and was having one plastic bottle without wrapper which was half filled with water in his hand.

3. On 17.04.2023 the police called me to the police station. I went thereto. The police enquired me as to whether the accused who were locked in police lock-up were the same person who I had seen on 06.04.2023. I

told the police that they were the same boys.

4. The deceased Rajinder was my nephew in relation. I had given statement to the police on 07.04.2023. The main road where I had allegedly seen the accused was about 2½ kilometers away from my house. The spot where I had seen body of the deceased existed 1½ kilometers away from the spot where I allegedly had seen the accused, by road and was about one kilometer away therefrom by short-cut/pedestrian path. I had disclosed the police that I had received telephonic call of Kashmir and had gone to the spot where body of the deceased was lying. Confronted with statement of the witness recorded under Section 161 Cr.PC Exhibit P4/PW2 (subject to proof) wherein it has not been so recorded. I had not disclosed to the police that body of the deceased Rajinder was lying in the bushes near crusher. I had disclosed the police that 200-300 persons were present on the spot. Confronted with statement under Section 161 Cr.PC Exhibit P4/PW2 (subject to proof) wherein it has not been so recorded. I had disclosed the police that the boy present on the spot had told me that he had seen two boys with the deceased Rajinder and had shown me one photograph on the spot. Confronted with statement under Section 161 Cr.PC Exhibit P4/PW2 (subject to proof) wherein it has not been so recorded. I had told the police that the accused were scared and were looking behind at me.

Confronted with portion A to A of statement Exhibit P4/PW2 (subject to proof) wherein it only has been written that both the boys were scared and one boy was staring at him. I had told the police that one of the boy had kept one wet shirt on his head. Confronted with statement under Section 161 Cr.PC Exhibit P4/PW2 (subject to proof) wherein it has not been so recorded. I had also told the police that the other boy had kept parna (towel) around his neck like a muflar and was having one plastic bottle without wrapper which was half filled with water in his hand. Confronted with statement under Section 161 Cr.PC Exhibit P4/PW2 (subject to proof) wherein it has not been so recorded. On 07.04.2023 I alongwith my wife on a motorcycle had gone to the spot. Initially Punjab police was present on the spot and lateron HP police had also reached over there. I cannot recollect the time when I reached the spot on 07.04.2023. I cannot tell the exact distance in between the bushes and crusher on the spot. It is incorrect that I had not gone to the spot on 07.04.2023 nor I had seen body of the deceased lying on the spot nor I made any statement to the police. It is incorrect that on 17.04.2023 I had not identified the accused. It is incorrect that on 06.04.2023 I had not seen the accused coming out of the bushes. It is incorrect that I am deposing falsely.
