ORDER

1. Accused Rajendra Damodar Kharate is hereby convicted on admission of the offence punishable under Section 6(a) r/w 24 of Cigarettes and Tobacco Act, 2003 by virtue of section 252 of Cr. P. C.
2. The accused is sentenced to pay fine of Rs.200/- (Two Hundred only) in default of payment of fine he shall suffer S.I. for seven days, for the offence punishable under Section 6(a) r/w 24 of Cigarettes and Tobacco Act, 2003.
