The supplementary case record of being Sessions Case no.13/2020 was sent by Ld. Additional Session Judge, 1st Court, Lalbagh, Murshidabad showing the accused Baban Laha arrested on the strength of the warrant issued by the Additional Sessions Judge, Lalbagh, Murshidabad. The Ld. Additional Sessions Judge, Lalbagh, Murshidabad directed to produce the accused before the transferee court on 21.03.2023. On the basis of the Order of the Ld. Session Judge, Lalbagh in respect of the production of the accused Baban Laha, the case record is put up.

On the basis of the put up petition the bail petition for the accused Baban Laha @ Dinesh Laha is filed. Ld. PP-in-charge is present physically. He has submitted that other accused persons have been enlarge on bail and it is left to the Court to consider his bail petition by raising objection thereto.

Ld. Defence counsel has submitted that the accused could not appear before the Ld. Additional Sessions Judge, Court, Lalbagh on the date fixed due to the fact of not knowing the date of his appearance before the Ld. Court. He will not jump the bail if bail may kindly be allowed. He did not prefer any bail petition before the Hon'ble High Court Calcutta.

Heard both sides. Considered.

It is to mention here that the above named accused was on bail previously and as he was not to get known the date of his appearance before the Ld. Court, the W/A was issued against him. On being perused the record it is found that the accused was on bail previously and if the bail is allowed for him there will be no chance of his fleeing away and there will be no chance of hampering and tampering of the evidence and to this effect the accused Baban Laha @ Dinesh Laha should be enlarged on bail. The accused Baban Laha @ Dinesh Laha may find an interim bail of Rs. 5000/- with two sureties of Rs. 2,500/- each of the same value of whom one must be local with direction to remain present on the date fixed subject to the satisfaction of Ld. ACJM, Lalbagh, Murshidabad i.d. JC.

To 20.04.2023 for production if bail bond is not furnished.
