The plaintiff is most respectfully prays that this Hon'ble court be pleased to pass a judgment and decree against the defendants for recovery of suit claim as follows.

1) To direct the defendants to pay a sum of Rs. 57,896.99/- with respect to loan account No.19058050000131 with future interest at 8.75 percent plus 2 percent penal as per the particulars mentioned in the loan ledger extracts filed separately compounded quarterly from the date of suit till its realization.

2) In case the sale proceeds out of the sale of hypothetized property are not found sufficient to discharge the entire decree amount the plaintiff is entitle to recover the same from the defendant personally for the balance amount.

3) To permit the plaintiff to bring attachment/sale of hypothicated Live Cattle Stocks.

4) And to pay all the court cost and interest and incidental charges by the defendant and to grant such reliefs that this honourable court deems to fit to grant such other reliefs under the circumstances of this case in favour of the plaintiff in the ends of justice and equity.

This suit coming on this day for final disposal before Sri. Raghavendra.D, B.Com, LL.B Prl. Senior Civil Judge and JMFC., Bhadravathi, in the presence of Sri.B.S Mahesh Kumar Advocate for Plaintiff and defendant placed exparte.

By pronouncing the Judgment it is ordered and decreed that, the suit of the plaintiff is hereby decreed with cost in part.

Further it is ordered and decreed that, the defendant is hereby directed to pay total due amount of Rs.57,896.99/- with simple interest at the rate of 6% per annum.

Further it is ordered and decreed that, the plaintiff bank is at liberty to sell the hypothicated property in due process of law.

Further it is ordered and decreed that, the defendant is hereby directed to pay the decree amount within 2 months from the date of this order. If the defendant fails to pay the decree amount within time, the plaintiff bank is at liberty to recover the same in due process of law.
