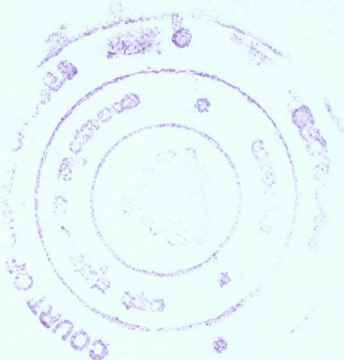

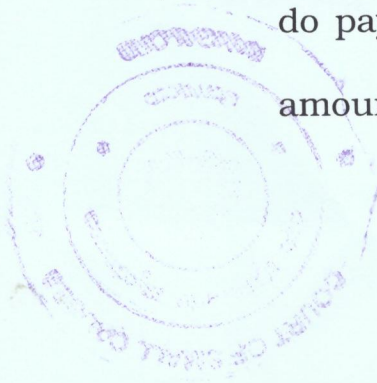

ORDER

The defendants are hereby directed to pay an amount of Rs.28.000/- with future interest at the rate of 6% p.a., on due amount of Rs.24,219/- from the date of suit till its realization to the plaintiff within 2 months from the date of this order.

And it is further ordered and decreed that defendant do pay to the plaintiff sum of Rupees ⁷⁰³² ~~7032~~ =00 being the amount of costs incurred in this suit, as by memorandum
