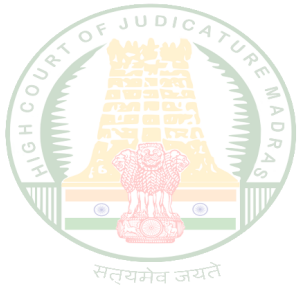

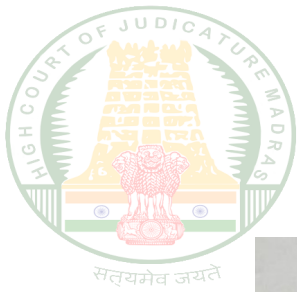

TERMS OF THE MEMORANDUM OF COMPROMISE: -

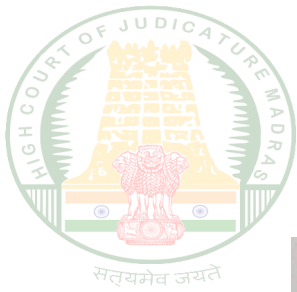
1. The Plaintiff has registered trade mark for its product "Deepam Oil" the label of the same is attached herewith as Annexure-C.

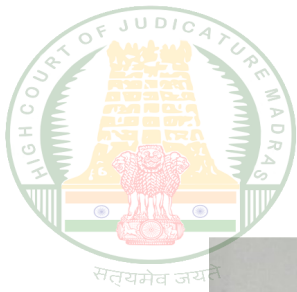

The Defendant has changed their trademark from GRAMIYUM DEEPAM OIL to **"GRAMIYUM LAMP OIL"** on 10th June 2022 i.e. immediately upon receipt of desist notice dated 10th June 2022 from the plaintiff and had already removed all the products of **"Gramiyum Deepam Oil"** and the Defendant undertakes not to use the Trademark of the Plaintiff, **"DHEEPAM"** or any other mark which is similar or identical to the Plaintiff's registered Trademark and the Defendant has also changed their mark as **"GRAMIYUM LAMP OIL"** in the label with a colour combination as projected in the design of the label attached with this memo in **Annexure-A**.
 3. The Defendant undertakes not to use the get up, colour scheme, arrangement of the colour which are closely similar to the get up and logo of the Plaintiff's product **"DHEEPAM OIL"**
 4. The Defendant undertakes to use the trade dress, colour scheme and get up for their product **"GRAMIYUM LAMP OIL"** and/or any other trade dress, colour scheme and get up for their product which will not be similar to that of the Plaintiff's product **"DHEEPAM OIL"**.
 5. The Defendant undertakes not to Pass-off the goods as and for those of the Plaintiff's by adopting the similar or identical get up, colour scheme, arrangement of the colour, get up and logo of the plaintiff's product **"DHEEPAM OIL"** and its Pouch / Packing material.
 6. The Defendant has already erased/removed all the products under the **"GRAMIYUM DEEPAM OIL"** in its possession or control with the mark labels, as described in Annexure Band pouches claimed to be deceptively similar to the Plaintiff's **"DHEEPAM OIL"**.
