1. The matter was kept for hearing on 24.09.2024.
2. At the outset, Ld. Adv. Mr. Yash Dadhich, appearing on behalf of the Petitioner, submitted that the Commission may adjournment in the present matter as the Petitioner want to file an application for amendment in the present matter. It is requested that the Commission may grant two weeks' time to the Petitioner to file the said application.
3. Ld. Adv. Ms. Ranjitha Ramachandran, appearing on behalf of the Respondent, submitted that since last two hearings, the Petitioner has sought the adjournment in the matter. She submitted that the Commission may also allow the Respondent to file

The Petitioner would be at liberty to file rejoinder reply within a week' time in the IA filed by the Petitioner.
