DAILY ORDER

1. The above matters were kept for hearing on 22.12.2023.

2. At the outset, Mr. J.R. Bavalia, appearing on behalf of the Respondent PGVCL submitted that the Respondent PGVCL has not received copy of the Petition from the Petitioners till date.
