DAILY ORDER

1. The matter was kept for hearing on 29.07.2025.
2. Ld. Adv. Mr. Utkarsh Singh appearing on behalf of the Petitioners submitted that the present Petition has been filed by the Petitioners under Sections 61, 62, 86 (1) (e) of the Electricity Act, 2003 read with other applicable provisions of the Electricity Act, 2003 seeking for appropriate order with regard to connectivity sought for during the period from 04.10.2023 to 31.08.2024 by certain class of consumers.
 - 2.1. He further submitted that the issue of 30% of banking is pending before the Hon'ble High Court of Gujarat. Hence, the Commission while adjourning the matter today, may list the present matter in the first week of October 2025.
3. We have considered the submissions made by the Petitioner. We note that the present Petition has been filed by the Petitioners under Sections 61, 62, 86 (1) (e) of the Electricity Act, 2003 read with other applicable provisions of the Electricity Act, 2003 seeking for appropriate order with regard to connectivity sought for during the period from 04.10.2023 to 31.08.2024 by certain class of consumers.

3.1. We further note the statement of the counsel appearing for the Petitioners that since the issue of 30% banking is pending consideration before the Hon'ble High Court of Gujarat, the Commission may adjourn the matter and keep it for hearing in the first week of October 2025. In view of this, the matter stands adjourned. The Petitioners are directed to appraise the Commission about final outcome of the said matter by the Hon'ble High Court of Gujarat.
