DAILY ORDER

1. The present matter was kept for hearing on 18.07.2025.
2. At the outset, Ld. Adv. Mr. Utkarsh Singh, appearing on behalf of the Respondent GETCO, submitted that the Respondent GETCO has yet to file its reply in the matter. He requested that the Commission while granting adjournment, may also grant three weeks' time to file a reply in the matter.
3. Ld. Adv. Mr. Aditya Singh, appearing on behalf of the Applicant/Petitioner, submitted that there is no objection to the adjournment sought by the Respondent. He further requested that the Commission may also grant one week time to the Applicant/Petitioner to file rejoinder reply in the matter.
4. We note the statement of the Ld. counsel for the Respondent that GETCO is yet to file the reply in the main matter and has sought three weeks' time for filing the same. Accordingly, let the reply, if any, be filed by the Respondent, within three weeks' time from the date of hearing with a copy to the Applicant/Petitioner. The Petitioner would be at liberty to file their rejoinder reply, if any, within one

week time with a copy to the Respondent. As the Respondent GETCO sought adjournment in the matter and there is no objection to the same by the Applicant/Petitioner, the matter stands adjourned in the interest of justice.
