**DAILY ORDER**

2. At the outset, Ld. Adv. Mr. Utkarsh Singh, appearing on behalf of the Respondent GETCO, submitted that the Respondent GETCO has yet to file its reply in the matter. He requested that the Commission while granting adjournment, may also grant three weeks' time to file a reply in the matter.
