1. The present matter was kept for hearing on 24.07.2025.
2. Ld. Adv. Mr. Utkarsh Singh appearing on behalf of the Respondent submitted that they have filed their reply and will be on record by today. He further submitted that the Bank Guarantee has already been expired on 30.06.2025 and the same has not been extended by the Petitioner till date.
3. Ld. Adv. Kiran Joshi appearing on behalf of the Petitioner submitted that they have not received copy of reply filed by the Respondent and need some time to file the Rejoinder to reply filed by the Respondent. She further submitted that on behalf of the Petitioner she undertake to extend the Bank Guarantee.
