Adv. appearing for the Petitioner while no objections to the short adjournment sought by the Respondent GETCO on account of personal difficulty of their legal counsel, requested the Commission to fix the next date of hearing keeping in view the urgency involved in the matter. It is submitted that the present Petition pertains to RE Project wherein extension of time is sought for completion of project due to various unforeseen events and also huge investments made by them. It is therefore necessary to decide the matter in time so that in extended time period, the work will be completed and project may be energized and generator will not suffer on commercial aspects.
4. Heard the parties. We note that the Respondent GETCO has requested for short adjournment in the matter due to personal difficulty of its legal counsel, which is not objected by the Petitioner, however, requested the

Commission to consider the short date looking at the urgency in the matter.

5. Considering above, we decide to adjourn the matter for today and with consent of both the parties, the matter is listed on 08.10.2025 at 11.30 AM.
