Learned counsel for the appellant inter alia contends
as under:

- (i) No offer of possession was ever made to the appellant as would be clear from the perusal of the record. Therefore, the delay possession charges should be from the due date of possession till the possession is actually handed over.
- (ii) Issue raised by the complainant-appellant about the encroachment in the common area of the project has not been dealt with by the Authority.
- (iii) Appellant is not liable to pay interest in terms of direction given by the Authority in para 16(v) of the impugned order.

Appeal be registered.
