There is delay of 107 days in filing and 34 days in refiling of the present appeal. Besides, there is no compliance of proviso to Section 43(5) of the Real Estate (Regulation and Development) Act, 2016. A query has been put to counsel for the appellant how this appeal can be entertained. No clear answer is forthcoming. However, he prays for short adjournment to seek instructions.

Learned counsel for the appellant submits that he may be allowed to withdraw the application of waiver. Allowed to do so. The application is dismissed as withdrawn.

Learned counsel for the appellant is directed to deposit the entire amount as pre-deposit to comply with the aforesaid proviso of the Act on or before the next date of hearing.

Now the case stands adjourned to 03.03.2023 for seeing the compliance of this order.
